

June 12, 2019 Waynesboro Electoral Board Canvass for Republican Primary June 11, 2019

Elizabeth Bouldin-Clopton Called The City of Waynesboro Canvass Meeting for the Republican Primary of June 11, 2019 to order at 8:06a on Wednesday June 12, 2019.

In attendance: Elizabeth Bouldin-Clopton, Chair, Frank Lucente, Vice-Chair, Robert Horowitz, Secretary and Lisa Jeffers, Director of Elections/Registrar.

We have organized and processed the Canvass by Ward in alphabetical order: Ward A, then Ward B, Then Ward C & Ward D. The Chair and Vice Chair verified election results for each ward, as did the Director of Elections. The entire Board and the Director of Elections checked results and materials from each envelope for all the Wards

There were no Provisional ballots, so the Electoral Board proceeded to verify the voting process by Ward.

Wards A, B, C, D and the CAP envelopes 1A, 1B, 2, 2A, 3, 5, 6, 7 and 8 were addressed. Each ward had the correct number of signed Officer of Election Oaths (Ms. Bouldin-Clopton witnessed and signed for Ward C), The Correct Ballot Count Report, The Entry/Exit Permits/receipts, Statement of Results with Voting machine signed printouts , Incident Report for Ward D only (others blank), Pollbook Data (ISync) and Closing Checklist and Printed Return Sheet with attached signed Voting Machine Tapes, as well as Voting Machine Memory Card, keys and fobs. All envelopes had been signed off and sealed by at least 2 Officers of Election.

The result tapes produced by the voting equipment, all signed by all the Officers of Election at each Ward, were compared for accuracy and matched with Ballot Count. The tapes were read out by Electoral Board Chair, Elizabeth Bouldin-Clopton, and verified by the Electoral Board Vice Chair, Frank Lucente and confirmed by The Director of Elections.

Ward A had 178 ballots cast, Ward B had 528 Cast, Ward C had 332 ballots cast. And, Ward D had 765 ballots cast. The CAP Ward had 55 absentee ballots cast. The total Votes cast in the City of Waynesboro for the June 11, 2019 Republican Primary was 1,858 of the 13,14 registered voters. This meant 13.94% of registered voters voted in this off-year one party primary.

Emmett W. Hanger, Jr. was chosen as the Republican Candidate for the Virginia 24th District Senate Seat and G. "John" Avoli was chosen as the republican candidate for Virginia 20th District House of Delegates Seat.

The June 11, 2019 Republican Primary Results Tally¹ will be attached to the end of these Canvass Meeting Minutes.

The Waynesboro Electoral Board voted unanimously to certify the election results. The Secretary of the Board, Robert Horowitz, and the Director of Elections, Lisa Jeffers signed and sealed the Certificates of Election. The Registrar will see that they are delivered to the winners. Robert Horowitz, Secretary, delivered all envelopes containing SOR and all other forms, as well as, envelopes of ballots cast and unused ballots to the Clerk of the Court.

The Canvass was closed at 9:35a.

After a brief discussion about the space issue The City Manager wanted to pursue, the Board agreed to invite not only the City Manager but, at least, two City Council Members to our next Electoral Board Meeting scheduled for July 10, 2019. This was in keeping with a prior agreement between the City manager and two City Council Members that any discussion pertaining to issue concerning the Director of Elections/ Registrar's and Electoral Board would be discussed by representatives of all parties concerned.
