The applicant hereby agrees to abide by City Code Section 94-43, Publication of Notice of Application for a certificate of public convenience and necessity shall be published by the applicant in some newspaper published in the city twice weekly for the two weeks prior to the date on which the application is heard.

Per City Code Section 94-45, for each certificate of public convenience and necessity granted under this article, there shall be paid to the city a certificate fee of \$25.00 for each vehicle for which a certificate shall be granted. No additional fee shall be charged for renewal of any certificate granted. This fee is in addition to regular license fees.
