

ORDINANCE NO. 2023-



**AMENDING SECTIONS 30-58(h)(3)(a) AND (b),
66-3(c)(f), 86-28(a), AND 86-139(a) OF THE CITY CODE OF THE
CITY OF WAYNESBORO, VIRGINIA TO UPDATE
STORMWATER UTILITY SERVICE CHARGES, REFUSE SERVICE CHARGES,
WATER UTILITY SERVICE CHARGES, AND WASTEWATER UTILITY
SERVICE CHARGES AND RATES AS HEREIN SPECIFIED**

BE IT ORDAINED by the Council of the City of Waynesboro, Virginia, in order to increase Stormwater Utility charges for each stormwater Equivalent Residential Unit as of July 1, 2023, that subsections (a) and (b) of Section 30-58(h)(3) of the City Code are hereby amended and re-adopted as follows:

30-58(h)(3)

- (a) The monthly utility fee shall be the ERU rate of \$4.84 per month for one ERU until modified by City Council. An ERU is 1,600 square feet of impervious surface.
- (b) The monthly fee for Multi-Family Residential and Nonresidential shall be calculated by dividing impervious surface on the subject property by 1,600 and multiplying by the ERU rate as established by the City Council except that no fee shall exceed 244 ERU's per month.

FEE SCHEDULE FOR SINGLE FAMILY RESIDENTIAL		
Single Family Residential	ERU's	Monthly Fee
Tier (1) <1,200 sq. ft.	0.5	2.42
Tier (2) 1,200 to 3,000 sq. ft.	1.0	4.84
Tier (3) >3,000 sq. ft.	2.0	9.68

Except as amended hereby, Section 30-58(h) shall remain in full force and effect.

BE IT FURTHER ORDAINED by the Council of the City of Waynesboro, Virginia, in order to increase refuse service charges as of July 1, 2023, that Section 66-3(c) and (f) of the City Code are hereby amended and re-adopted as follows:

Sec. 66-3

- (c) For a fee of \$20.00 per month per cart, the City shall provide one roll-out cart and shall provide one pickup of the contents of such cart weekly.

- (f) The rule of computing monthly fees under this Section shall be the number of carts multiplied by the number of pickups per week multiplied by \$20.00

Except as amended hereby, Section 66-3 shall remain in full force and effect.

AND BE IT FURTHER ORDAINED by the Council of the City of Waynesboro, Virginia, in order to increase the water rate per 1,000 gallons used from \$5.36 to \$5.85 and increase the tiered monthly service charges based on water meter size as of July 1, 2023, that subsections (1) and (2) of Section 86-28(a) of the City Code are hereby amended and re-adopted as follows:

Sec. 86-28

- (a) Rates for water shall be as follows:

- (1) A service charge for each water connection made to the City water system shall be assessed monthly pursuant to the following fee schedule:

5/8-inch meter	\$9.85
1-inch meter	\$25.68
1 1/2-inch meter	\$48.13
2-inch meter	\$83.87
3-inch meter	\$145.57
4-inch meter	\$176.34
6-inch meter	\$220.86
8-inch meter	\$269.73

- (2) All water used will be billed at a rate of \$5.85 per 1,000 gallons.

Except as amended hereby, Section 86-28 shall remain in full force and effect.

AND BE IT FURTHER ORDAINED by the Council of the City of Waynesboro, Virginia, in order to increase the sewer rate per 1,000 gallons used from \$8.96 to 9.23, and increase the tiered monthly service charges based on water meter size as of July 1, 2023, that Section 86-139(a) of the City Code is hereby amended and adopted as follows:

Sec. 86-139

- (a) Wastewater user charges shall be based on the metered water consumption on the premises. The monthly wastewater user charge shall be billed at a rate of \$9.23 per

1,000 gallons. Monthly service charges shall be billed based on the size of the water meter on the premises as follows:

5/8-inch meter	\$14.95
1-inch meter	\$28.30
1 1/2-inch meter	\$52.97
2-inch meter	\$83.35
3-inch meter	\$117.72
4-inch meter	\$160.06
6-inch meter	\$255.25
8-inch meter	\$400.29

Except as changed hereby, Section 86-139 shall remain in full force and effect.

This Ordinance shall take effect immediately upon adoption, and the rates shall be applicable to all usages that occur beginning July 1, 2023.
