INSTRUCTIONS

Business Personal Property Return

The Virginia Tax Code 58.1-3518 requires all business owners, including home-based businesses, to file a Business Personal Property Return and asset list each year. It is the responsibility of every taxpayer who owns, leases, rents, or borrows tangible personal property that was used or available for use in a business and was located in the City of Waynesboro as of January 1st to report all tangible personal property. This form must be received by the Commissioner of the Revenue's office **on or before May 1st** of each year.

Failure to file and provide an asset list will result in a statutory assessment as allowed in 58.1-3519 of the Code of Virginia.

Returns received after May 1st will be assessed a late filing penalty of 10% or \$10.00 (whichever is greater).

Tangible Personal Property is everything other than real estate. It includes furniture, fixtures, tools, machinery, computers, telephone equipment, signs, canopies, leased equipment, hand tools, non-licensed vehicles and trailers, and any other equipment used in the business to earn income.

All equipment must be listed on an asset list that includes original purchase cost, original purchase date, and a description of the equipment. Total original cost includes all costs incidental to acquiring and placing an asset in use, including but not limited to the purchase price, freight, labor, and installation. **Original cost means the cost paid by the original purchaser of such property from the manufacturer or dealer.**

If you have failed to file or provide an asset list in previous years and continue failure to comply with the Code of Virginia you will be subject to an onsite audit of all equipment.
