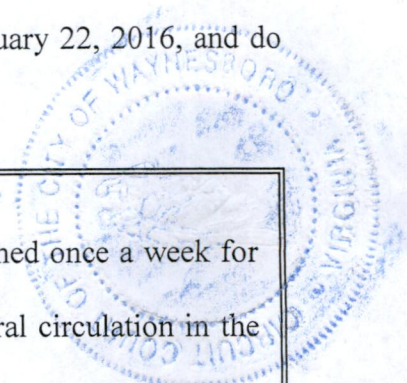
ORDER OF PUBLICATION
